BACKGROUND & PURPOSE



The Region will be replacing noise walls located on the west side of Guelph Line (Regional Road 1) from 40 metres north of Longmeadow Road to 100 metres south of Longmeadow Road including a return on the south side of Longmeadow Road.

The replacement of the existing noise walls is required due to the condition of the walls (cracking and separation of the existing walls at the posts). The existing noise walls vary in height, however, on average are approximately 2.2 metres.

The existing walls will be replaced with concrete noise walls at an approximate 3.0 metre height. The Region is completing detailed design for the noise wall replacement and the purpose of tonight's homeowner's meeting is to discuss the design and answer any questions related to the installation of the noise walls.








NOISE WALL INSTALLATION

- Installation of the noise walls is anticipated to take approximately 10 to 12 weeks (weather dependent).
- The existing concrete walls will be removed, and temporary fences will be installed until installation of the permanent concrete noise walls is complete.
- Tree protection will be installed where required.
- Some pruning of larger vegetation may be required and will be reviewed with the homeowner in advance.
- All impacts to landscaping will be restored by the contractor.
- Features such as existing side fences may be impacted by construction activities, however all features will be restored by the contractor.
- Noise walls will be installed 0.3m off property line where possible.




